What is the Ultherapy® Décolletage Treatment?

On June 20, 2014, the Ulthera® System received FDA-clearance to non-invasively treat the chest to improve lines and wrinkles on the décolleté. This new indication for the System allows it to be used as a stand-alone Ultherapy® treatment or as an add-on to the Ultherapy® lifting treatment administered on the face and neck.

What is unique about the Ultherapy® Décolletage Treatment?

While there are many energy-based devices on the market that are used to treat wrinkles and lines on various surfaces of the skin, the Ultherapy® Décolletage Treatment is now the ONLY non-invasive procedure specifically indicated by the FDA to improve lines and wrinkles on the chest.

What are the key benefits of the Ultherapy® Décolletage Treatment?

How does the Ultherapy® Décolletage Treatment work?

Unlike lasers, radio frequency, surgery and other technologies, non-surgical Ultherapy bypasses superficial skin to deliver the right amount of ultrasound energy at the right depths and the right temperature. This energy triggers a natural response under the skin, jumpstarting the regenerative process that strengthens weak collagen and produces fresh, new collagen. The treatment also uses traditional ultrasound imaging, which allows practitioners to see the layers of tissue they are treating, ensuring the treatment energy is delivered to where it will be most beneficial.

What kind of results are expected?

Some patients see an initial effect right after their treatment, but the real results are visible after about three months as new collagen works smooth skin on the chest. Most patients enjoy fresh, young collagen for at least a year after their procedure. As skin continues to age, future touch-up treatments can help keep pace with the natural aging process.

When will the Ultherapy® Décolletage Treatment be available?

The Ultherapy Décolletage Treatment will be available in more than 1,500 physician practices across the United States, starting third quarter 2014. The Treatment is already cleared in more than 40 other countries worldwide and has been selectively available since 2012.
